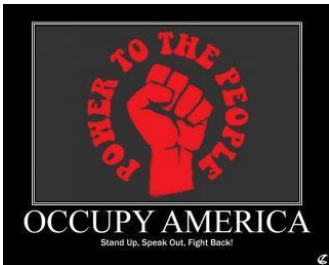

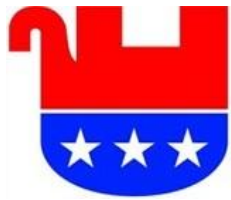
The post election period has been difficult for most Americans to accept. With the re-election of Barack Obama, a great many saw that his continued assault on the American way of life will bring chaos. It has been, perhaps, even more difficult for Tea Partiers. Within the Tea Party movement, there have always been those who understood who Barack Obama is and what his agenda would bring.

With the rise of the Tea Party movement in 2009 and 2010, it was only natural that the Republican Party would see an opportunity to use the populist movement to promote their candidates. No one can fault them for taking advantage of this opportunity. Prior to the 2010 election, Tea Party groups willingly submitted to Republican control. The cooperation between the Tea Party and the Republicans seemed essential if the Democrat's grip on Washington was to be broken. The new populist excitement brought many new Republican voters and the Republicans gained both in the State Houses and in Washington. In return for the grassroots support, the House Republicans appointed John Boehner as Speaker of the House. This establishment progressive continued on with business as usual. As speaker, Mr. Boehner has failed to set the agenda and allowed the Obama administration to run roughshod over conservative positions. It would not be extreme to say that the House Republicans have been complicit in Obama's revolution.

As the 2012 election approached, the Republican Party failed to support Tea Party candidates and in some cases actively opposed them. In typical top-down progressive control, the Republican Party nominated one of the most progressive presidential candidates possible. Their rejection of Tea Party candidates and the rebuff of Libertarian delegates at the National Convention sealed the Republican's fate. 3.8 million Republican voters who had participated in 2010 failed to participate in 2012. To deflect the error in judgment, the elite top-down Republican leadership then begins a campaign to declare the Tea Party movement dead. This control and destroy policy is of particular interest to the Saint Augustine Tea Party. This Florida-based Tea Party has spent over 20 months fighting for its independence from Republican operatives which concluded as a result of a lawsuit. As a result of this experience, the staff of this publication has engaged in an investigative effort to determine the relationship between the Tea Party movement and the Republican Party. The result of our findings appears in the article, which follows.

Official GOP Policy for the Tea Party in Florida Is it National Policy as Well?

Based on interviews from Tea Party sources, and from Republican sources, a clear policy, to control or destroy Tea Parties, has been imposed by the Republican Party on Tea Party groups throughout the State of Florida. According to Tea Party sources, the initial rallies in 2009 were organized by individuals with few if any political activists among them. The organizers were made up of practical people displaying incredible amounts of common sense. These early organizers coalesced into core groups which formed the many grassroots Tea Party groups that followed.

One such group, formed under the leadership of Bree Lee Johnson. After a successful rally was held on April 15, 2009 at the Castillo de San Marcos, St. Augustine, Florida, Mrs. Johnson, Incorporated, Just Patriots, Inc. According to public records, Mrs. Johnson was listed as the President, Secretary and the Treasurer of the Corporation. It was reported by early Tea Party members that during this phase the members never received any financial accounting for their activities. This led to a friction within the Tea Party group. Bree Lee, as Mrs. Johnson was known, vanished for three months in 2010 as she relocated from St. Augustine. The fragmenting Tea Party would become the St. Augustine Tea Party and it was ripe for Republican takeover and control.

During the same time period, other Tea Party activists saw the advantage of forming a Tea Party network within the State of Florida. The first organizational meeting occurred at Glenn Lord's business establishment in Jacksonville, Florida. The founders of the Tea Party network were successful in uniting 83 groups according to Jay Jacobs, a Tea Party network organizer. The early Tea Party network leadership was comprised of, mainly, grassroots independent people. But in their midst, Republican activists were also present. By February 2011 Republican influence in the network was such as to elect Patricia Sullivan, currently Lake County's Republican State Committeewoman, as chairman of the network. Rick Haven, also a network supporter and Jay Jacobs both confirmed irregular behavior in the election process and in some cases, manipulation of the bylaws. The grassroots leadership that gave the network its original direction was forced out. Control of the network by the Republican Party caused 10 independent Tea Party groups to withdraw immediately. Since then, the network has failed and many of the member groups are inactive. The first, and most successful project of the network, was the revitalizing of the faltering Tea Party group in St. Augustine. This was accomplished by organizing a Tea Party rally at Francis field in the historic district of St. Augustine. This occurred in September of 2010. One of the 2010 influential Republican network leaders was Larry Sheffield.

Saint Augustine Tea Party was Born

In August 2010, Larry Sheffield, a Republican Executive Committee (REC) member from Putnam County, met with the fragmented Tea Party group to reorganize it. Except for an email inviting her former members to join in the reorganization, Bree Lee Johnson was nowhere to be found. People who knew Mrs. Johnson claim that she was not a Republican operative. What is known, however: the Tea Party mailing list and the website became the property of the Republican Party operatives. With the introduction of two local REC Board Members, Randy Covington and Eric West, the only Tea Party in St. Johns County, Florida, renamed the Saint Augustine Tea Party (SATP), quickly came under the control of the Republican Party. The function of the SATP, from that moment on, was to showcase Republican candidates and to provide the REC campaign volunteers.

However, within a year, the critical differences between the principles of the Tea Party movement and the reality of the Republican Party's goals erupted into a separation that continues to this day. According to local Tea Party sources, the split in the SATP started in June of 2011, when the majority of SATP committees began promoting projects that diverted membership energy from the goals of the Republican Party. The Town Crier Committee being 'the' prime offender. The Town Criers started appearing at Town Hall meetings, County Commissioner meetings and presented itself to the public in Tea Party fashion. The Republican leadership was



terrified that the Criers were presenting the wrong image for their candidates. Town Criers quickly attracted media attention that was unacceptable as well. To resolve their problem, the Republican faction and leadership attempted to fire duly elected officers of SATP and restructure in secret meetings, much like Republican operatives did with the Tea Party network. Saint Augustine Tea Party survives Today as an Independent Tea Party

Members of the SATP had always thought that their experience was local and isolated. But, the only thing that was unique was that the SATP had freed itself of Republican control. Most Tea Party groups did not. When the SATP's Republican leadership was removed, GOP Party operatives did everything they could possibly do to destroy the Nation's Oldest City's original Tea Party. "Members of the local REC took our mailing lists, our website, canceled meetings, took our money, tried to take our name, attacked us in the liberal press and joined in with the leftists to marginalize us. They even went as far as trying to intimidate the owners of our meeting place," SATP members reported.

Control or Destroy Policy Widespread

This reporter had for some time heard rumors that Republicans at high levels were interfering with Tea Party groups. Then, there was a report that Republican State Committeeman and State Committeewomen were meeting and the main topic of conversation was that of control and/or destruction of Tea Parties. Inquiring about this, it was confirmed, that this was true, but off the record. On January 29, 2013, at the Republican Liberty Caucus meeting, Rick Hartley, Duval County State Committeeman confirmed in an open forum that, indeed, control or destroy was being discussed. It is now clear that the situation in St. Augustine is not unique. "Here's the situation, Tea Parties were used for the express purpose of electing Republicans. And for a while that seem to be a solution to stopping the left's agenda. Perhaps Tea Party people were a little naïve. But it is now clear that Republicans are about 'big government' and favor 'top down' control. The Tea Parties on the other hand, are about 'We the People', with 'bottom up' control, and small government. So, that is the problem. A good example of Tea Parties being used by the Republicans is Rick Scott's campaign. Running for Governor, he was all about the Tea Party and 'the People'. Now that he's Governor and the party politics come

into play, it's all about top-down," according to Dave Heimbold, SATP Media Chairman. "Now the 'cat is out of the bag' with Karl Rove's big money PAC planning to actively resist the election of Constitutional Republican candidates at the up-coming primaries. What we were fighting at the local level is now the official game plan at the National level. The Republican Party is basically committing suicide by shunning the grass root zealots; and worse, planning to actively use their financial advantage to defeat real patriots."

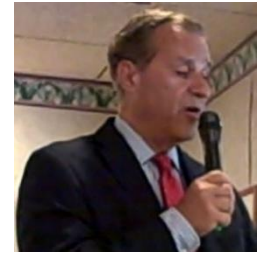

William Korach Returns as Featured Speaker at SATP Meeting

William Korach was the invited guest speaker for the Saint Augustine Tea Party's Regular Open Meeting.

Mr. Korach is the expert on the Public School system in Florida. He gave an update on the ratings of the United States education verses the rest of the industrialized world. The USA is ranked 25th out of 35. "The slide into 3rd world status has been going on for fifty years," he said. He passed around a graph which showed that, over all, the rating has been in the poor range for the last 40-50 years but the costs have sky rocketed. The USA is spending more and getting less. The USA receives a poor or failing grade for its educational investment.



Mr. Korach introduced the audience to Rev. Marty McCarthy, who started a chain of charter schools in Arizona. Once again, the Charter Schools out-performed the government schools and were less expensive. Here was a shining example of getting more education for fewer dollars. Rev. McCarthy heads Regent Schools of the Carolinas and is looking to expand in Florida. Mr. Korach said, "I am tired of throwing stones at the government schools". In other words, he and Rev. McCarthy may be looking to an alternative right here in St. Johns County.

The subject of the St. Johns School Board refusing to permit graduating students to give an 'inspirational' speech was discussed. Baptist Preacher, Doug Russo said, "And these School Board members are Republicans! And Christians"! He was flabbergasted, to say the least. Tom Rivers, former Board member, took out the minutes of a recent Board meeting and read, "Mrs. Slough opened the meeting with a prayer..." Then Mr. Rivers went on to say something to the effect that 'if she can say a prayer, why can't the students'?

The Tea Party group, as a whole, is basically disgusted with the predictable under-performance of the government schools, particularly, suppressing the graduating students 1st Amendment Rights.
