Tea Party right all along...

It has been reported, by numerous news services, that the Tea Party is enjoying a resurgence due to the Obama scandals. In Rep. De Santis' three and a half minute response to this question, he said, "Great question...very astute analysis...It is a mistake if we think there is a class of voters (grass roots) that we don't want...someone like Ron Paul, I don't agree with everything he says, but do agree on economy, the Federal Reserve, etc, etc...but if you listen to D.C...(they didn't get it)...the voters didn't see enough of a contrast between our candidates and theirs."

There were other excellent questions from the crowd. De Santis was totally in sync with the three scandals...Benghazi, IRS and AP. Rep. De Santis also reported that he had made an amendment to "de-fund Obamacare" but it never came to a vote.

Some thought that De Santis is doing about as much as he can, being just one of 435 members of the US Congress. Yet, from the questions in the audience, the voters want more from Congress. More, particularly, from the Republicans who insist on being so 'polite', so deferential to 'The President'. De Santis called Obama, 'The President', five times in the short three minute rejoinder to Patterson's question.

This, along with a clip of Rand Paul wringing his hands about the 'immigration issue' and saying "We are now a diverse nation" "OMG, the 'Hero' of the filibuster, falling for the Democrats' line of 'can't we all get along immigration song'. Chuck out the elephant and replace it with Daffy Duck," commented a Tea Party person present. Continuing, "We pray that Rep, Ron De Santis does not get sucked up in the marshland of D.C. and sticks to his guns. If he wants to call Obama, 'The President', that is up to him. Ron has First Amendment Rights, too. But if he wants to shed his blue blazer and tie for a tri corner hat and join us on St. George Street to see firsthand what his constituents and the public at large really think of 'The President', he is welcome."

Local Law enforcement addresses SATP Meeting

Commander Fricke fills in for City Police Chief



SAPD Commander Steve Fricke did a last minute stand in for Chief Loran Lueder at the General Meeting of the Saint Augustine Tea Party, at the Village Inn, on Tuesday, June 11th. The announcement of the event appeared in the Community section of [The Record](#). They also had a staff reporter present for the event.

Cmdr. Fricke opened his remarks with some impressive statistics about the low crime rate in St. Augustine. He added some anecdotal stories about some of his police friends who visit the city and have told him how safe they feel strolling the historic area without need to be 'carrying'.

The Commander said, addressing special events, "You don't have to worry about security, because we have already taken care of it". As for the City of St. Augustine, the Cmdr. Fricke held up a 16 page operations planner as a sample of the preparation taken by the City for an 'Event'; traffic flow, safety, rescue and a hundred other things that the public is not aware of and is taken for granted.

"The SATP can attest to the preparation which they did for the Tea Party Express event, last year at Francis field. Before getting the keys for the gates at Francis Field, there was an early morning, round table check off list of police, fire, emergency medical, trash, water and electric officials, etc. "Events are run like a well oiled machine", said a SATP spokesman.

After the Commander opened the floor to a Q & A session there were a variety of questions, mostly consisting of constitutional issues. For instance, there was a question about disarming the city residents in a disaster case. An example illustrating the point was the flooding of New Orleans, where an elderly lady was thrown to the floor and dis-armed, as seen on u-tube at that time. Cmdr. Fricke said, "The police in New Orleans were too busy getting people off roof tops and out of flooded building to be occupied with disarming the public." Some in attendance disagreed with his response. Regarding the second amendment rights, Cmdr. Fricke supported concealed carry, but expressed reservations about carrying a concealed weapon in to a bar with drinking a factor.

There was another question about a recent assault at the Conch House complex where Mojo of the Jaguars punched and knocked out a security guard in an altercation on the site. It had been reported that Mojo, who had hung around the area partying, punched the guard, and left before the police arrived. Asked about how he could get away with this when any other person would be arrested and thrown in the 'slammer', Commander answered, "This was a 'simple misdemeanor'. A police officer was not present thus a complaint must be made by the victim to the district attorney and run through the normal channels."

There was also discussion about the relationship between safety and liberty. The Tea Party audience, favored Liberty over safety. Regarding First Amendment issues, a Town Crier spokesman said, "In the 80 weekends that the Town Criers have walked down St. George Street we have always been appreciative of the way the police respect our 1st Amendment Right of Free Speech, and right of Assembly. This is not true on the federal property at the Castillo de San Marco. The Federal Park authorities routinely violate the First Amendment."

Cmdr. Fricke concluded with, "Four thousand people were arrested in St. Johns County last year, for a variety of reasons. A very low number for a vacation city were 5 million visitors come each year. This is a safe place to be and we are going to keep it that way." St. Augustine is in the top ten small city designations, in the Country.



Lance Thate, Chair of the SATP, thanked the Commander for coming and expressed Tea Party's support for local law enforcement. Those in attendance gave the Commander a standing round of applause.

“Audit The IRS Rally” in DC not covered by the Big 3 Media Outlets

The big three networks demonstrated their lack of professional journalism by not covering Capitol Hill “Audit the IRS Rally” on Wednesday. The entire network coverage constituted a mere four second sound bite of Sen. Ted Cruz on CBS. I still don't think it should have been that low. None the less, my disappointment quickly disappeared. Being in the midst of a multitude of such people is indescribable. More familiar people like Rand Paul, Glen Beck, Brent Bozell and Ted Cruz were great. I've never seen or heard Bozell so animated and incensed. It was a good day in Washington. The pictures here are not so clear. [The photos are just fine ED] They are of Cruz, Bozell, Beck and Paul.”

“I've heard Glen Beck speak very well on numerous occasions on the radio and also while at his Restoring Honor Rally in DC. 2010. But his speech today was something else entirely. I don't think I've ever heard anything better: Franklin Roosevelt, John Kennedy, Martin L. King, Ronald Reagan, Douglas MacArthur addressing the joint session of congress in 1951. Beck was magnificent! I'm not as big a fan of Beck as with some of his contemporaries on radio but he blew me away today. He spoke for at least forty minutes and every paragraph was a thrill. SATP Welcomes Paul Livingston to its Tuesday Open Meeting

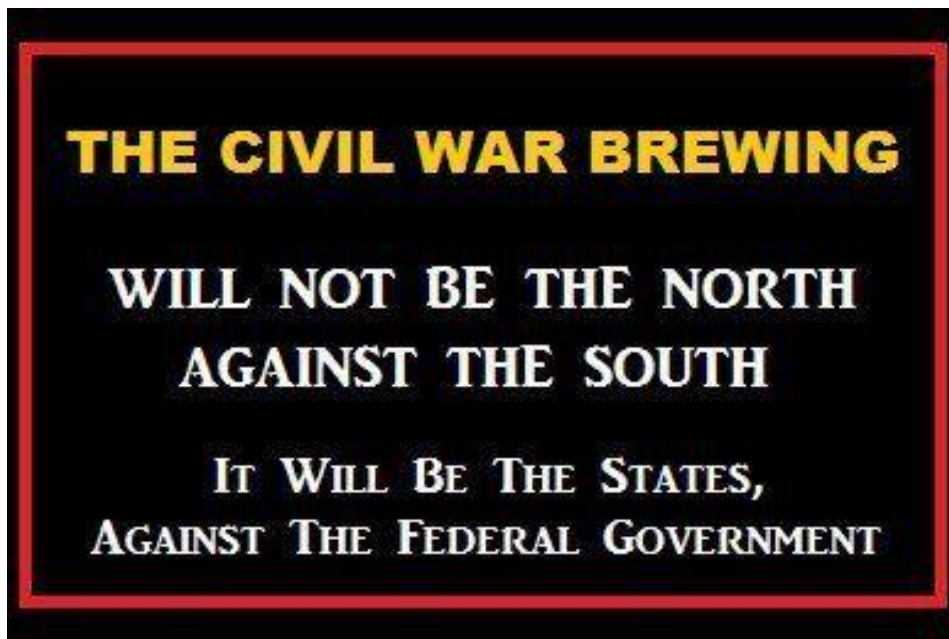

Paul Livingston, Northeast Florida Director for the Fair Tax Organization, addressed the members of the SATP at their regular bimonthly meeting at the Village Inn, located in St. Augustine, Florida. Though Mr.

Livingston had participated in several rallies held by the SATP in the past, this is the first time he has addressed a formal SATP meeting. Mr. Livingston explained that the Fair Tax would completely eliminate 75,000 pages of the current tax code. Income taxes on individuals, businesses and all payroll taxes would be eliminated and replaced with a consumption tax. Under the Fair Tax system employees would have no tax deductions from their paychecks. They would receive 100% of their wages and politicians in Washington, would no longer have the capacity to manipulate people's behavior with the current tax code. An important feature of Fair Tax is that all individuals would participate and all would be treated equally under the law. A rebate program, applied to all, would assure that no one would pay taxes for basic subsistence. To ensure that the income tax would not be added after the consumption tax was applied, the 16th Amendment authorizing the income tax would be eliminated as part of the Fair Tax code legislation, as proposed. The individual States would be responsible for collecting the taxes, thus eliminating the need for the IRS. According to Mr. Livingston, "The best way to get rid of the IRS is to enact the Fair Tax." Recent scandals concerning the IRS have many people calling for the elimination of the agency. Mr. Livingston revealed that support for the Fair Tax bill in Congress is growing. A thoughtful question-and-answer session followed his presentation.

Tea Party Ordered Off Public Sidewalk



Today, the Town Criers made their rounds in the historic district of St. Augustine, Florida. They are such a familiar sight that the City of St. Augustine Police Department barely takes notice as the Criers exercise their constitutional Right to Free Speech and the Right to Assemble.

The Town Criers have been free to engage the public on the public streets, continually, for over two years without harassment. “The Criers, ever mindful of their responsibilities to their fellow citizens, do not block or obstruct the use of these public right of ways, said a Town Crier member. “We engage in our civil liberties in a completely lawful manner,” he continued.



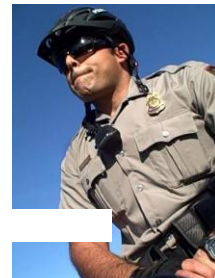
Today the Town Criers decided to greet the motorists on South Castillo Drive, as they have done in the past. “The cars driving by started honking their horns. They loved the sign that says, Abolish The IRS and they showed their approval with thumbs up, shouts of approval and more horn honking. So, we waved back in appreciation. It just happens. The public loves the Tea Party, our flags and our signs. The Abolish The IRS sign got its debut today. But, the ‘Federal Establishment’ hates the Tea Party. The Country is becoming a Police State under Obama. The IRS attack on the Tea Parties applying for tax exemption is just the most recent abuse of the Civil Liberties of the Tea Party Movement. It was at this point that we saw a Park Ranger hurrying down from the Castillo de Marco to confront the Criers. This has happened in the past,” according to the Criers present.



Tea Party records reveal that assaults on First Amendment Rights by the Park authorities as follows:

- The first was on July 4, 2011. A small group of Town Criers wandered onto Federal park property at the Castillo de San Marco. They were informed that they must leave or go to a free speech zone. The group chose to leave.
- The second time was on November 5, 2011. Again, Town Criers carrying flags and signs were instructed by Park authorities that in order to stay, they must go to a free speech zone. This zone is at the south end of the property. People engaging in free speech must stay in that area and cannot engage in free speech while standing on the sidewalks. The Criers stood on the grass and engaged the public as they passed by on the sidewalks. Transgressions were enforced.

- The third time was on April 14, 2012. The St. Augustine Tea Party held a rally on the fort grounds. The area was posted with signs stating, Free Speech Area. Participants were forbidden to step on the sidewalks. Teddy Gonzales, recovering from a broken leg injury, was ordered to leave the sidewalk, in spite of his difficulty with mobility while riding on a device which could not maneuver on the grass.
- The fourth time was on February 9, 2013. Three individuals went to the Castillo de San Marco for a photo op. The Park Ranger shown here, though polite, also insisted that we depart. He departed after being reminded of his oath to preserve, protect and defend the Constitution of the United States. The Town Criers departed at a time of their own choosing.

Today, American Patriots Had Their First Amendment Rights Assaulted, Yet, Again By The Feds On A Public Street

The Castillo de San Marco's Security Officer, Jill Jaworski, informed the Town Criers that they were not in a First Amendment area. [Every square inch of America is a First Amendment area ED] The following exchange occurred.

Park Ranger: "This is not a First Amendment area."

Town Crier: "This is a public street."

Park Ranger: "We own to the center of the right way."

Town Crier: "That may be true. However, in order for the road, the curb, the underground utilities, the storm sewers and the sidewalk to be constructed, the Federal government granted an easement across their property. That easement granted the public right of way. With that easement the Federal government gave away control. You have no authority here."

Park Ranger: "You can walk here, but you have no First Amendment Rights on this side of the street."

Town Crier: "We will not leave."

Park Ranger: "I will let it go this time, but next time I will take action."

It seems clear to this reporter, that Federal regulations and Presidential Executive Orders are taking precedence over Constitutional rights. The First Amendment to the Constitution of the United States reads,

"Congress shall make no law respecting the establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for redress of grievances..."

“By attempting to enforce Park regulations over the expressed Right of Free Speech, the Park Ranger violated her oath of office,” Tea Party members stated. “This is not a condition that exists only at the Castillo de San Marco, but is systemically present in all Federal agencies and departments. The Saint Augustine Tea Party’s First Amendment Rights were recently violated in Jacksonville, Florida. The Tea Party reports that freedom of speech was curtailed at Charles E. Bennett Federal Building on May 21st, 2013 by the Federal officer pictured here. Tea Party personnel were denied access to Federal property much in the same manner that occurs in St. Augustine. The only difference, between the Federal Government’s attempt at tyranny in Jacksonville and St. Augustine, is that the public right-of-way was respected on Bay Street in Jacksonville. Hundreds of Tea Party protesters engaged traffic, as it passed the Federal building last month. Yet, today a Park Ranger tried again to single out and silence the Tea Party on a public sidewalk used by everyone passing the Fort on foot.
