A Look at Connecticut's Shleep

On December 14, 2012, Adam Lanza fatally shot six adult staff members and twenty children in a mass murder at Sandy Hook Elementary School in Newtown, Connecticut. In response, a controversial, wide-ranging

gun control law was passed in Connecticut, on April 4, 2012. Among other things, it required gun registration on or before January 1, 2014. Now anything the state considers to be an assault weapon or magazine holding more than 10 rounds needs to be registered. Failure to comply will be prosecuted as a felony. It has been reported that more than 20,000 weapons have been registered with the state of Connecticut, according to Mike Lawlor, who is the governor's undersecretary for criminal justice.

When government is not lawful, what is the public's duty?

".....the right of the people to keep and bear arms shall not be infringed" does not require a lawyer or a court to interpret its meaning. The reading of the Constitution of the United States of America reveals that the Constitution and its amendments are the supreme law of the land. From that perspective, Connecticut has committed an unlawful act. So why are the citizens of Connecticut lining up to surrender their heritage? Is supposed safety more important than liberty? "Our duty is to resist. Consider Hitler's use of gun registration to control who had a weapon and who didn't. Hitler did not have to institute gun registration because it existed when he took power. He just used it to his purposes. He disarmed the Jews and then killed them. The unarmed civilian Europeans were at his mercy; he showed none. We have an occupant in the White House who has demonstrated, clearly, that he rewards his friends and persecutes his enemies. Are you going to trust Obama with gun registration? His people and the Unions will be armed, the people won't," a Tea Party spokesman said.



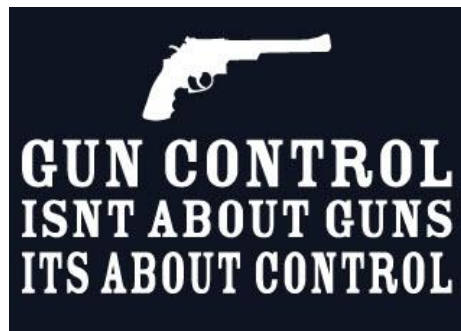
Saint Augustine Tea Party started last year defending the second amendment

So, it is this year

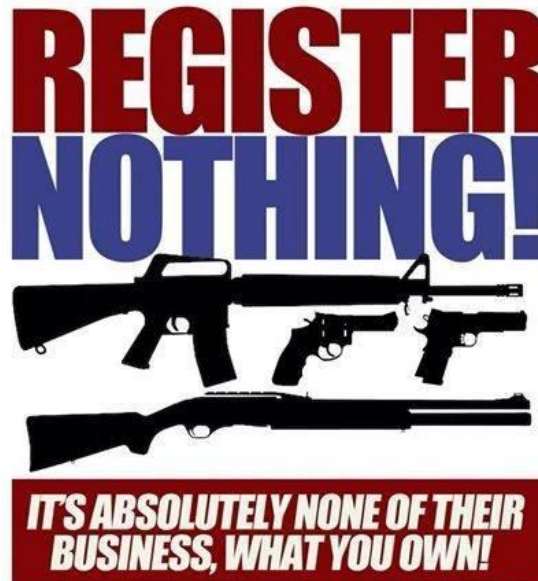

Today was a cold winter day in Florida. Gray skies, no sun, temperatures in the upper 50s, dampness in the air and a wind chill that made it feel colder than it really was. That’s how long-term Floridians would assess the situation. Of course,

This reporter has been covering the activities of the Town Criers for some time and has witnessed numerous happenings. But this is a first; in the midst of the crowded street, the man pictured above pointed at the Town Crier group and loudly proclaimed, “These are the patriots, the real patriots, the true patriots!” He repeated this numerous times and, in the process, the crowd paused and embraced the Tea Party presence. It was truly an exceptional outpouring. In the middle of the excitement a Crier, in a loud and commanding voice pronounced, “the progressive movement’s over; we are in a new era.” There were smiles and nods among the public and expressions of acceptance of the idea. There was one exception, however, the Town Criers reported: “A left winger, who had earlier tried to engage us with talking points, was shocked at what he was witnessing. So he reached down into his soul for the right response. He came up with the middle finger gesture. When criticized by the public, he claimed the First Amendment!”

Constitutionalists rally at the Capitol Second Amendment primary focus

Florida Citizen's Alliance's rally "Rally in Tally"

"Success is measured in many ways. Our objective was to keep the "Ball in play and moving forward". And we certainly did! Due to global warming, or NOT, because of the resulting cold weather, the Capitol Authorities moved our event inside. This was hugely appreciated by all. We had over 150 attendees, strongly committed to protecting our 2nd Amendment in every way possible, including State Sovereignty," Florida Citizen's Alliance event organizer, Keith Flaugh reported. The rally was held in a conference room on the 22nd floor of Florida's Capital building. There were 11 speakers, all speaking from varying positions but all united in supporting the Second Amendment Preservation Act, the Second Amendment rights and State Sovereignty as expressed in the ninth and 10th Amendments. The 'Alliance' made a united front in their 'war' to strengthen the Second Amendment, in Florida, against the anti-gun zealots at the Capital. "The only two downsides were Senator Greg Evers, who just didn't show and didn't offer a reason and Governor Scott, who was unable to talk to us briefly when we stopped into his office. We were not able to schedule an official meeting ahead of this event, but we did alert his staff and hoped he would take 5 minutes to affirm his personal commitment to the Second Amendment and State Sovereignty under our Constitution." Mr. Flaugh continued. "All in all, it exceeded most of our expectations," he concluded.

Commenting on Governor Scott's failure to address the constitutional patriots who assembled at the capital, David Heimbold, SATP media chairman said, "It has been apparent for over a year, that Gov. Scott has shifted alliance from being the Tea Party Gov, to the progressive Republican leadership values of bloated, huge and just plain big government of Karl Rove and Company.[See Vol 2 No7 of the Publication April 2, 2013 Gov. Scott to Flagler college Ed] It appears that having the progressive Republican's leadership endorsement is more important than principled constitutional governance. It is hard to imagine that the Tea Party Movement and the corrupted Republican Party ever had anything in common."

Rally participants seek out their Representatives and Senators

The second phase of this event was for those attending to visit the Governor's office and their individual Representative's and Senator's offices. It had been anticipated that this would be the second day of the new legislative process. But for some reason, after the "Rally in Tally" event was scheduled, lawmakers decided to delay their activities. As a result, the public areas of the Capitol building were nearly empty, with staffers securely behind closed office doors. Missing, were the busy halls, the media and the public mulling around the rotunda. In fact it appeared to this reporter, that the only people in the building where the constitutional participants of the Florida Citizen's Alliance.

The elusive Senator Greg Evers

The failure of the legislators to be in their offices, caused an already angered electorate to have to deal with their staff. It was reported that a sizable group of people went to Senator Greg Ever's office to question his failure to appear at a rally as planned. The staff failed to provide any reason for the Senator's unexpected no-show. Senator Evers had agreed to speak at the rally and was on the agenda as a speaker.

The following day a woman known for her temperate tone confronted the evasive Senator Evers and received no explanation for his failure to meet his commitment to the Florida Citizen's Alliance rally. She reduced the Senator's comments to, "What Bull S___!" This kind of arrogance on the part of our elected officials is alienating Americans at an unprecedented level. "It explains the call that is frequently heard demanding removal of all of them. This is no longer a Republican, Democratic thing," a Tea Party person said. According to "Florida Citizen's Alliance", Florida Representative Dane Eagle has committed to file the 2nd Amendment Preservation bill in the House, consistent with the content provided him in Sept., and Representative, Matt Caldwell, who was present at the rally, expressed his continuing support. 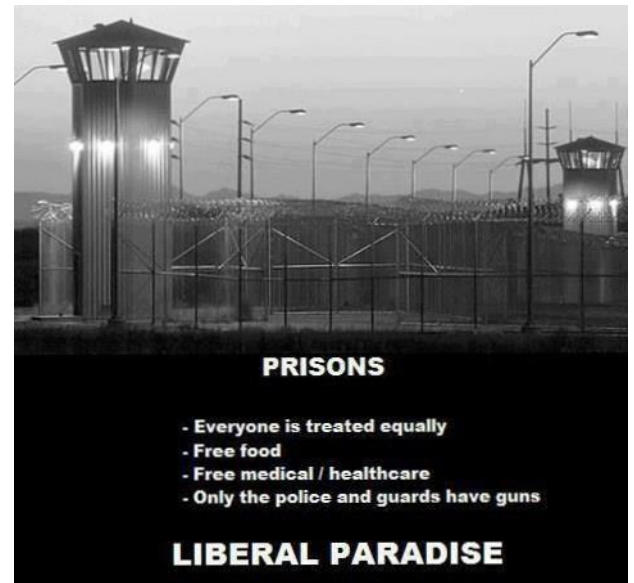

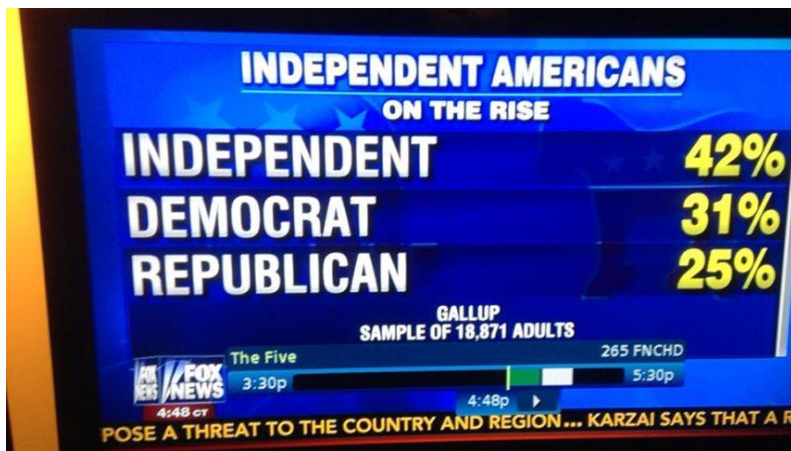
Town Criers rock Scarlet O'Hara's

Increased media exposure was cited as the reason for the increase in activities. The labors of several Town Criers on January 17, 2014, resulted in a series of articles being written for this report. They were featured and got national distribution. It is estimated the Town Crier’s activities were sent to 252,977 people. “Not too shabby for a handful of people. This does not count our normal distribution,” a Town Crier said.

Gallup poll doesn't stand up

A winter day in St. Augustine

In spite of temperatures in the upper 40s and a brisk wind making it feel much cooler, the Town Criers were able to muster four individuals to kick off their new program. Traffic was light on St. George Street with only the hardiest of "snowbirds" present.

The enthusiasm of those present did not confirm the results of a recent Gallup poll. Gallup claims only 22% of the population are supporters of the Tea Party. The poll was based on a random sample of 1031 adults aged 18 and older living in the 50 US states and the District of Columbia. The poll was conducted on December 11, 2013. Perhaps, when you do a telephone interview, you get the Gallup results. When confronted with "politically incorrect" signs, blazing the simple truth of their statement, coupled with the Gadsden flags, on a face-to-face encounter with the people, the Gallup numbers crumble. An estimated 4200 people were exposed to the Town Crier's activity in the streets, today. Support for their presence has been a consistent nine out of ten since they first made their first appearance on Flag Day 2011. While the Crier's polls are not scientific; it may well be much closer to reality of the situation.

Politically incorrect signs are the beacons of truth

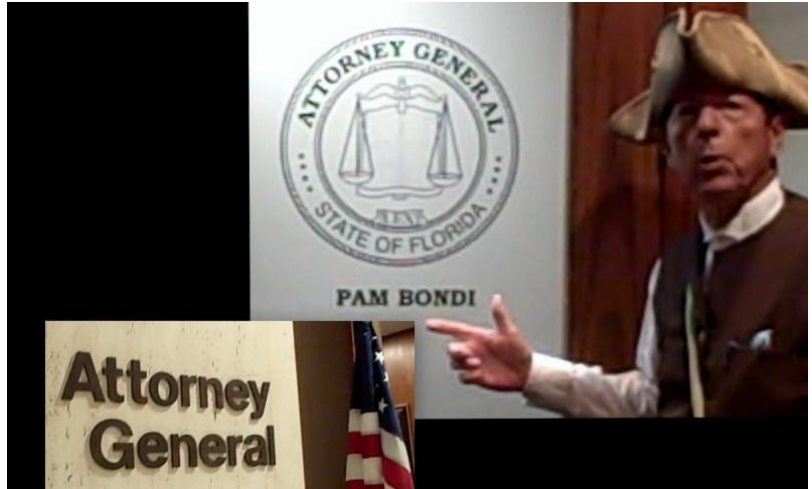

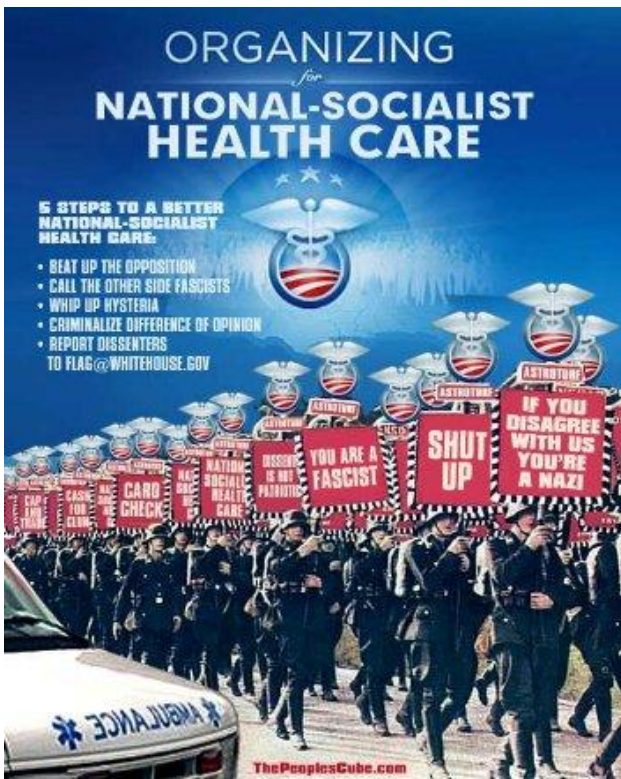

There are now eleven States who are appealing Obama's over-reach in giving extensions and modifying the Affordable Care Act at will. Attorney Generals in West Virginia, Alabama, Georgia, Idaho, Kansas, Louisiana, Michigan, Nebraska, Oklahoma, Texas and Virginia wrote Sebelius a letter last week expressing concern that HHS has proposed a rule which “both compounds illegal executive action and fails to protect the privacy of consumers using the health insurance exchanges.”

But Attorney General Bondi has not jumped on board in this combined effort.

Now, we ask you: Shouldn't Attorney General Bondi have resisted the take-over of the health care system in Florida instead of joining CEO Patrick Geraghty, of Florida Blue, in his attempt to 'transition' 300,000 by 'direct enrollment' into Obama-care?

Bondi has the duty and authority to join other State's Attorney Generals in pushing-back Federal intrusions into State business. It is written in plain language in Florida Statute 16.52. Bondi is not an employee of Florida Blue. Or is the \$25,000 donation just hush money? “Our question is: Did the donation by Florida Blue have any influence on her decision not to join the other eleven State AGs to resist the long reach of Obama's Bureaucrats into Florida's affairs?”, said a Tea Party spokesman yesterday.



“We suggest that Bondi return the money to Florida Blue and tell Obama's agent, CEO Geraghty, to shove it,” Heimbold concluded.

McDaniels has Marine counter terrorism experience

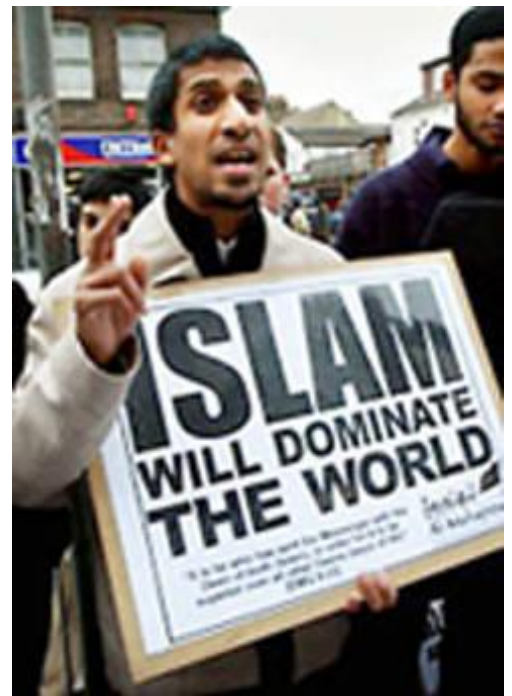
