## First Amendment Rights alive and well at the Castillo de San Marcos in St. Augustine, Florida

A year ago today, the National Park Service had a policy of First Amendment Areas, called 'Free Speech Zones', at the Castillo de San Marcos. The policy was based on Department of Interior regulations. The Saint Augustine Tea Party (SATP) and its Town Crier

Committee, refused to acknowledge the validity of these regulations, based on the Constitutional rights granted in the First Amendment. Resistance continued over a three-year period. On July 4, 2013, a citation for demonstrating without a permit was issued to Dave Heimbold, SATP Media Chairman. The citation was later rescinded after the incident was exposed by intensive media coverage, which was initiated by this publication. Today, the Saint Augustine Tea Party reports that the vast majority of the grounds and sidewalks are now open to Free Speech. They also expressed their gratitude for the help which the Superintendent of the Castillo de San Marcos, Gordon Wilson, provided in getting the Dartmouth such a favorable location in the Park facility. The St. Augustine Tea Party's Dartmouth was surrounded by tens of thousands of accepting and friendly people this Fourth of July. The great ship was used as a photo op for several thousand pictures. "Clearly, the St. Augustine Tea Party knows the secret to having a successful rally. It's simple. You don't invite people to a rally; you take the rally to the people. Due to the activities of our Town Crier Committee, our Tea Party 'rallies' with the public on a weekly basis on St. George Street. We are the most active Tea Party in the State of Florida these days," a Tea Party member said.

"We have come a long way since our first Fourth of July celebration in 2011. In those days, we carried a Tea Party sign and a flag. We only came into contact with those we encountered as we passed among them. We carried no political signs, as our Republican handlers were terrified that we would embarrass them. The timid approach back then, is much the same as the Republican's timid approach today. The GOP leadership in our Tea Party was voted out in September of 2011. Located in rural St. Johns County on the Smith family farm near Hastings, Florida, is a most unique gun shop. Wayne Smith, pictured upper right, has been holding classes on Saturdays, 9 to 12 and 2 to 5 at 9700 Hastings Blvd., Hastings, Florida for many years. Instruction, advice, sales and service relating to firearms are the order of business. But over the years, it has become the scene of a wide variety of patrons from all walks of life, who often just hang out, to discuss events past and present. The Constitution is a frequent subject. Note the liberty sign, in the picture above. Below the sign are several 50 caliber rifles. The folks that hang out in this shop understand that the bottom line for the preservation of liberty is the Second Amendment. A 1000 yard firing

range is available to the shop's customers. Political conversation, particularly of the current circumstances, is always on the agenda. Historical connections spice up the conversation. #### **ALL HANDS ON DECK**

With a sweet little voice, came a bold committed statement to me, a former Navy Nurse, "You're wearing my white dress!" I thought to myself, "Yes, I am, but 21 years later, and for a different war!" I was stirred by the connection she revealed between us. We were decidedly sisters of wartime—givers of our hearts and lives to wounded warriors of two unique wars. I felt proud to meet 95 year old Mary and proud to be a part of a Standard bigger than my own, set to

Mary Basso Long joined us on the Fourth of July, this year, at "The Dartmouth," parked at the Castillo de San Marcos. ("The Dartmouth" is a replica of one of the Boston Tea Party Ships from which English tea was dumped into the Boston Harbor, in 1773. This new replica is a reminder of the current "Tea Party's" mission to

stand up for the rights of the American People, to question government "orders" (which border on tyranny) and to preserve the Principles set down by the Constitution. Mary and four other Veterans of four foreign wars were recognized on "The Dartmouth" for their exemplary service the USA, and other countries fighting for their Freedom.

Mary Long is a distinguished World War II Army Nurse Corps Veteran who recognized my white Nurse's Uniform as one which she had worn, proudly, during the war. She spoke candidly about wartime in Europe — her duties in France, Germany, Austria and Italy. Tents were set up in each location of fighting, and the Army Nurses and Medical Staff followed the troops into battle. Her assignment, in the 58th Division of the Army Corps, was to care for the causalities with chest and belly wounds. She didn't want to work in surgery and, consequently, spent most of her time on her knees. Since the guernies were low to the ground, she knelt over wounded bodies all the way through Europe, a hardship she spoke of several times!

Mary went through the war with four other Army Nurses, all comrades of the war. She chuckles about one very special Army Nurse Friend who always asked for Mary's accompaniment to the common showers. Since, she had to undress in the shower; she wanted Mary's promised protection from onlookers.

Mary Boss, 95 years old, spent one year in the European Corridor. She was scheduled to go to Japan, next, but this "duty" fell through. She returned home to her husband, an Air force Pilot during the war. Much to her chagrin, Mary Boss lost him to complications following surgery for an ulcer; she states, "They forgot to give blood to his liver during surgery and he never recovered. It was many years ago, now." When asked if she ever wanted to marry again, she said, "Why would I? I loved my husband!"

We paid tribute to four Veterans on the 4<sup>th</sup> of July, 2014, at Castillo de San Marcos, and to Mary, our oldest Veteran who is the recipient of French Legion of Honor! Other Veterans present included: Paul Hooker, Lance Tate, Yvonne's husband and daughter, and Barbara Patterson. All offered their lives for their country, in the name of Freedom. They are worthy of honor, respect, and support by the USA.

The Tea Party will continue to endorse these inalienable rights to the Vets because of their service to this country. God bless the inherent connection of all Veterans who pledged their allegiance to our Flag, and their life to our Country; to insure Freedom to the people of the most beautiful land on earth, the USA!

## Denver Cook has a Message: "Loosen Up!"

Imagine all the challenges of running for political office. Now, add this to the list: How about a fine for every yard sign put in the 'wrong' place? How about \$118.00 for the first offense, \$268 for the next misplaced sign, with a maximum penalty of \$500 and/or 60 days in jail! Welcome to St. Johns County, Florida.

No, that's not all. "Serious violations could result in required appearances before the Special Magistrate...could result in fines of up to \$5,000.00 per day...Fines are per day for as long as the violation exists. For the first violation, it's up to \$1,000.00 per day." Repeat violations, up to \$5000 per day."

The State of Florida already limits Free Speech and authorizes the Counties of Florida to Enforce the Florida Building Code (FBC). The FBC also regulates 'Signs' and requires permits. The enforcement arm of St. Johns County is Article 7 of the St. Johns County Land Development Code. This 40 page document is a good example of how the 'government 'continues to over-regulate commerce and your personal life.

An example in Article 7 is Part 7.04.00, Political Campaign Signs, C. Location, which reads "Political Campaign Signs shall be placed on private property only..." This is absolutely an assault on free speech, which is bad enough, since no speech is more sacred than political speech. Adding to this, recently, the County figured they would take it a few steps further. Apparently, the Commissioners didn't think the State's codes were tough enough. So, they added fines and jail time. It appears suspicious, to this reporter, that the Commissioners are further infringing on the exercise of Freedom of Speech, in St. Johns County, immediately preceding an election, by threatening new candidates about Political Campaign Signs.

"Running for public office is one of the greatest expressions of Free Speech to redress grievances. This ordinance could be enforced in an impartial manner and create an atmosphere of 'fear of jail time' over a misplaced sign and have a true financial cost for those running." said Candidate Cook concluding "Today I am urging the County Commission to take action on this ordinance so that it is at the State enforcement level". Candidate Cook wants the newest batch of fine and threats to be overturned, immediately.



The facts and quotes above were presented to the Board of County Commissioners on July 15, 2014, by Candidate Denver Cook. He was referring to a letter sent to him by a Code Enforcer on April 28, 2014; "This information is provided to all Candidates running for Political Office" is the opening sentence of the letter in the picture on left which lists the fines and threat of jail time for misplaced political yard signs. This edict was signed by James L. Acosta, Supervisor, Code Enforcement Program, St. Johns County Board of County Commissioners, Growth Management/Code Enforcement Division.

On Tuesday, July 15, 2014, Candidate Denver Cook, District 4, addressed the Commissioners and pointed out the difference in tone and substance of the State position on political signage and that of St. Johns County. "The State of Florida took a very different path whereby signs will be removed and taken to the nearest yard where "every effort to place a courtesy call to your campaign office and advising of sign removal and the location of the maintenance yard where the signs have been stored, because we know your signage is expensive." Compare this to St. Johns County's threat of heavy fines and jail time for a misplaced sign.

There was absolutely no response to Candidate Cook's statement from the Board. They sat there in silence.

"Obviously, the Commissioners are either restricting free speech for their own political interests or they approved of this insane, gargantuan over-reach of punitive power by abdicating their responsibility of protecting the "Rights of the People" in favor of protecting Mr. Wanchick and the other bureaucrats by deferring to them. It appears that those who have power intend to keep it at the expense of the First Amendment. Mr. Denver Cook will be a formidable Candidate. He is a number cruncher. He could easily replace Mr. Wanchick and do the job of Commissioner of the 4<sup>th</sup> District, as well. As for Mr. Acosta, he should resign in shame," Tea Party members present said.


### It's Not About Hobby Lobby and Contraception

The Hobby Lobby decision by the Supreme Court proved to be a flash point for many with a left leaning viewpoint, it was painfully obvious, from letters to the editor and internet comments, there was a much larger

issue than whether or not Hobby Lobby's employees were able to obtain the full range of contraceptives available on the market today under their company benefit plan.

For the most part, the discussion was being held on a very surficial level. The real issue at hand was the fundamental principles of Americanism. What do I mean by "fundamental principles?" I mean the philosophical principles on which the foundations of this nation were laid, the bedrock upon which everything that followed rested. America was the first country to be founded on the idea that individuals, by the act of being created, were entitled to certain basic rights. The operative word here is "basic." These rights did not come from any government, king,



or any other human being. In other words, every human being is created equal in the sense they have the

same basic rights, and cannot be legitimately deprived of them (except by forfeit) by any other person or group of persons.

This was not a new concept. For centuries the idea had its roots deeply planted in philosophical and religious discussions arising from "The Great Conversation of Western Civilization." The immediate antecedent to the American ideal is to be found in the works of the "Enlightenment" by such authors as John Lock, David Hume, and Algernon Sidney. The exploration of "natural rights" and limited government by these great scholars provided the mold in which the very idea of America was cast. The polemic of the Enlightenment was built on the foundations of Greek and Roman philosophers and religious scholars out of the Judo Christian tradition, who are too numerous to mention in the space allotted.

What exactly are these "basic" rights and where are they to be found in our founding documents? Many would say our Constitution, but they would be wrong. While the Constitution provides the framework of our Federal Government and provides protections against tyranny, it does not provide the philosophical principles, which support the foundations of our country. One must go back to the Declaration of Independence to see these sacred rights laid out in plain language. In the 2<sup>nd</sup> paragraph of the Declaration this phrase can be found;"--- are endowed by their creator with certain inalienable rights; among these are life, liberty, and the pursuit of happiness." That is it in a nutshell, the foundation of America. Let's take a quick look at what these three enumerated rights represent. A basic right is like a contract against the world, which if you don't violate its terms, must legitimately be respected by every other person in the world. You cannot legitimately be separated from these rights by any other person or group of people; only you can forfeit them. Your life is your exclusive property. You may live it and do what is necessary to sustain it, so long as you do not, by force or fraud, interfere with anyone else's right to do the same. Your liberty is your guarantee of freedom to do as you wish, so long as you do not, by force or fraud, interfere with anyone else's right to do the same. Your pursuit of happiness is the guarantee of freedom to engage in those activities that add meaning and richness to your existence. This would include, but not be limited to; freedom to engage in religious activity of your choosing, freedom to engage in the vocation or profession of your choice and to reap the benefits of your labor, freedom to engage in the arts and to create, the freedom to speak you mind without fear of reprisal, and the right to acquire and quietly enjoy property, so long as you do so by peaceful means and respect the rights and property of others. Basic rights inherently attach to every individual, not to select groups of individuals. When a man made (read government) right conflicts with a basic right, then the man made right can only be exercised by using government force against another individual or class of individuals. This violates the very concept of basic rights.

These core rights are the essential foundation of all that has come since our founding. And what has been the result? Consider this: When Thomas Jefferson penned those immortal words in the 2<sup>nd</sup> paragraph of the Declaration of Independence, we essentially obtained our food, heated and lighted our homes, traveled by land and sea, practiced medicine, and clothed ourselves the same way we had for the preceding 5,000 years. The steam engine had yet to make its appearance, there were no electric lights or motors, the internal combustion engine had not been invented, immunization would be a century away, and antibiotics nearly two centuries. There were no telephones, radios, or televisions, and communications took days, weeks, and sometimes months to reach their destinations.

In the 238 years since the Declaration of Independence, all of those things have come to pass. We have gone to the moon, have medical miracles extending life and enhancing its quality, we travel at near the speed of sound, there are cell phones and iPods, and we enjoy leisure and quality of life as never imagined in the 18<sup>th</sup> century. A government designed to insure the liberty of its citizens and to protect their basic rights unleashed a torrent of human creativity! When men and women were free to engage in their own pursuits and to reap the rewards of their hard work and creativity, they produced and exploited the frontiers of science and ingenuity as never before. They weren't working for a king, a warlord, or a dictator; they were working for themselves! Freedom, individual freedom, catapulted America from an agrarian society to the moon in two centuries, a 5,000 year leap.

In the 18<sup>th</sup> century we drew the blueprint for a society that would become the marvel of the modern world. In the 20<sup>th</sup> century we began to chip away at the foundations that marvel. Through convoluted interpretations by our courts, and usurpations of authority not granted to our elected officials, we slowly began to undermine the very principle that made us great. We talked a lot about rights granted to us by our government, but failed to recognize how those "government granted" rights were in contradiction to the basic rights granted by our creator. A famous philosophical scholar once said, "When you encounter a contradiction, check your premise." Do we resolve these contradictions in favor of rights granted by other men (the government), or do we resolve them in favor of the inherent basic rights granted by our creator? The pages of history are littered with the ruins of societies built on trust in men.

The calamity facing our nation is heightened by the fact that we now have several generations who have not been schooled in the founding principles of our nation. They no longer possess the intellectual tools to recognize when some faddish movement collides with bedrock foundational principles in a way that jeopardizes the very freedom they enjoy. If you are not even aware of a clash in values, how can you be expected to resolve an issue in favor of a time-tested principle?

Enter the Hobby Lobby debate. The US Supreme Court ruled, in a close decision, that Hobby Lobby had a right to refuse to provide their employees certain contraceptives as a benefit under the company's health insurance policy due to religious conviction. This evoked an outcry from a broad section of society (most of who were not employed by Hobby Lobby) against the company's policy and the decision. The general flow of the debate was that these female employees had a right to all contraceptives at no cost to themselves. The opposing views were generally of a nature of, did these contraceptives terminate a pregnancy, or should all policies cover contraceptives? Even the Supreme Court did not get to the fundamental issue; they argued on the basis of religious conviction.

This is a case that should easily have been resolved on the basis of fundamental American Principle, "Man is, and of right ought to be free." If Hobby Lobby or anyone else starts a business and offers products or services to customers, and jobs to employees, they should not be interfered with so long as customers willingly buy their product, and employees willingly accept the jobs on the terms agreed to by both parties; Hobby Lobby should be free to act as it chooses so long as it does not initiate force or fraud against any other party. Potential customers are free to refuse to purchase from anyone who does not conduct their business in the way the potential customer would like. Potential employees are free to refuse to work for anyone who does not provide wages, benefits, and working conditions suitable to them. Under this scenario everyone's basic

rights are protected. You can express your disapproval of any company's policies by refusing to work or shop there, but it is not the government's place to enforce certain segment's preferences at the expense of another.

In the case in question, Hobby Lobby is still being required to provide health insurance or incur substantial penalties. This cannot be reconciled with basic American foundational principles. Remember, under our founding principles, Hobby Lobby is entitled to pursue happiness (start and operate a business) so long as they do not initiate violence or fraud against anyone else, and leave others to pursue their happiness. When the government that is charged with protecting those rights uses its power to force Hobby Lobby to give to another party that which it does not wish to give, then the government has forfeited its legitimacy. The key point to understand is that if you support government or anyone else using illegitimate force against another party, you have just empowered it to take like actions against you in ways you probably have not thought about. So you see, it is not about Hobby Lobby and contraceptives; it is about the fundamental principles of American freedom.

The well thought out principles of 1776 has made the citizens of this country the most fortunate in the entire world. I fear we are about to trade our birthright for a bowl of porridge.

Large numbers of local residents expressed contempt for the Obama administration, demanding impeachment. They were equally contemptuous with the Congress for failure to take action. Tea Party members on duty report that they frequently heard, "We must take the Senate back in November." But when questioned further, this did not necessarily translate into Republican victories. In fact, it translated into "We the People" must take the Senate. The progressive leadership of both parties continues to fail to recognize that the Tea Party movement is alive in the people.

The people distrust State government and expressed concern about the corruption in local government. When asked about First Amendment attacks by the County Commissioners, they were deeply concerned. The number one issue on their minds, however, is the crisis at the southern border. Time and again, the public demanded that the border be secured. Is anyone in Washington listening?
