Birthright, Citizenship, and Frivolous Dispensations

14th Amendment Section 1. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States;

There are two schools of thought about how a child should be awarded his Citizenship. One method is now very wrong, but the other is right and sorely indicated.

The theory - termed Jus soli - holds that a child becomes a Citizen of the soil upon which he was born. Jus soli has become the umbrella that shields the American 'Anchor Baby' irrational. In this time of hemispheric migrations, from south to north, from less-developed countries to those more developed, from poorer nations to the richer ones, from unstable countries to those more stable, Jus soli is a really bad - potentially suicidal - idea. (See Globalism...)

The other, more reasoned approach to sorting out a newborn's Citizenship - referred to as Jus sanguinis - has nothing at all to do with the geography of one's birthplace, but rather with the Citizenship status of the child's parents. In other words, the child's first birthright is, naturally, to inherit the Citizenship of its parents. This is simple, straightforward and so much less confusing. And, dare I suggest, much less dangerous?

When the Pilgrims came to America, they and their descendants for the next century and a half, were all Subjects of the Crown, and therefore subject to the jurisdiction of the British Empire. As Kings are oft wont to behave, some become tyrants, which is why the American Revolution had to be fought. When the British went

home in defeat.... overnight, the former British 'Subjects' became American Citizens in their now-sovereign, brand new country.

But, as the new Constitution was fleshed out, the southern states would not stand down from the issue of slavery. So, the issue of slavery, the great hypocrisy ignored by many of those who'd just overthrown a brutal tyrant for their freedom, remained the snake under the table at the first Constitutional Convention. Seventy years later, the slavery issue would be resolved during a great blood-letting.

A year after the Civil War ended, the U.S. Congress passed the Civil Rights Act of 1866, the purpose of which was to ensure that black Americans were U.S. Citizens with the same rights as all other American Citizens. (Native Americans were excluded from this act, as they were considered Citizens of the tribes to which they belonged.) Another purpose of the CRA of 1866 was to override localized southern attempts to hinder former slaves from enjoying their new-found rights and freedom.

By 1868, the CRA of 1866 had been ratified by the states, so it became the 14th amendment to the Constitution. In 1884, in Elk vs. Wilkins, the Supreme Court ruled that Native Americans were not granted Citizenship by the 14th Amendment. (Native Americans received American Citizenship through subsequent Congressional legislation in 1924, 1940, and 1950)

In 1898, SCOTUS reviewed the case of United States vs. Wong Kim Ark. Ark was born in 1873, to Chinese immigrant-nationals who were living in the United States. Misinterpreting the 14th Amendment, a lazy Court inferred that Ark was an American Citizen (via Jus soli), which was never the 14th Amendment's intent. The purpose of the 14th Amendment was specific to the time and circumstance under which it became law, not as an invitation to be misconstrued years later by leftist politicians trying to enlarge their voter base, at whatever the cost.

The Supreme Court has made a few grievous decisions in its history. The Dred Scott Decision, which was handed down just a few short years before the Civil War erupted, comes to mind. But, the 1898 opinion, that the 14th Amendment also meant that Wong Kim Ark was automatically a U.S. Citizen by virtue of his birth on U.S. soil, even though his parents were not American Citizens, could one day soon prove to be an even worse turn of American jurisprudence.

The illegal immigration America has been subjected to for several decades now has to be stopped. 'Anchor Babies' are an invention of the left, disguised as 'fairness', but mainly used to the left's political benefit.

America is in no way constitutionally compelled to take in anyone who can sneak across our border. If we have no border, we have no country. Awarding American Citizenship via Jus soli is a recipe for the dissolution of what made America, America. There are legal pathways to American Citizenship. There is great trouble in store for any country which is careless enough to lose control of its borders, only to eventually award Citizenship to any Tom, Dick, and Invader.

So, Donald Trump is exactly right, that the current caravan of migrants coming up through Mexico must be turned back from our southern border. Estimates of illegal immigrants already in this country run well past ten

million, and maybe twenty. There's no knowing, the number of 'Anchor Babies' here, too....likely a million or more. But who could know the count, really?

It should be noted that the majority of the world's nations do not award Citizenship via Jus soli, but rather award it via Jus sanguinis, where it is tied to the Citizenship of the child's parents at the time of birth. It should be noted that India wisely did away with the Jus soli idea in the face of mass migration from Bangladesh.

It should be noted that all the nations of Europe award Citizenship via Jus sanguinis. Even so, ever-helpless Europe is being overrun by Muslim hordes from North Africa. Europe's days, of remaining European, are now numbered. It also should be noted that most of the nations of Central and South America, including many of its offshore Island Nations, the U.S, and Canada are nearly alone in the world when it comes to awarding Citizenship based on Jus soli.

Finally, it should be noted that the idea of Jus Soli, for determining U. S. Citizenship, has never been formally litigated in a U.S. courtroom, let alone argued in front of the Supreme Court. The 14th Amendment has been dangerously misinterpreted, with a hole poked in it you could drive caravan mobs through. Hopefully, Donald Trump will fix it, one way and another.

This ain't rocket science, America.



So the disposition of high office hangs in the balance between Communists and those who subscribe to the capitalist system and the Constitution. Joseph Stalin once said, "It's not the people who vote that count. It's the people who count the votes." The Democrats have a long history of subscribing to Chairman Stalin's comment. In the corrupt urban centers of America, there are always Supervisors of Elections who will find the necessary votes to prevail.

The mid-term election of 2018 is now in the process of losing voter confidence.

The first State of the Union address was given by George Washington on January 8, 1790. The internal structure of the Union from 1790 to the present has been one of considerable strength. Nights of Lights' Light Up

On November 17, 2018, the City of St. Augustine celebrated their 25th Annual "Light Up" of the "Nights of Lights" in the historic district of St. Augustine, Florida. With the flip of one switch, 3 million small white bulbs lit up the city for the holiday and winter seasons from November 17, 2018 to February 3, 2019. The glittering spectacle has become an internationally recognized event. The "Light-Up" event in the historic district attracts approximately 8000 people, with 5000 in the Plaza and the overflow of about 3000 on St. George Street and the Bayfront.

The St. Augustine Tea Party (SATP) has had a presence at the "Nights of Lights Light Up" event for seven of the last nine years. [SATP formed in 2010 Ed] According to Lance Thate, SATP Chairman, the Tea Party refrained from carrying politically sensitive signs during the "Light Up", because they were there to join with the public in the celebration. They simply carried a sign which identified them and they came in period clothing as the Tea Party's Town Criers. The SATP Chairman went on to say:

"The public would engage in our activities by joining us for photo exchanges. Those photographs were widely spread on social media. All of this changed, last year, as community organizer, Ron Rawls made his appearance with Black Lives Matter, the Occupiers and the "New Black Panther Party". In Saul Alinsky styled demonstrations, intimidation, fear, hate and racism emerged. The Tea Party unites people. The Progressive Communists divide."

The Black Supremacist Returns

Since last year's Nights of Lights Light Up, Ron Rawls has transformed himself from a Martin Luther King want to be, to a Malcolm X image. This transformation is visible in his demonstrations throughout the past year. This troubled many within the city government. It ultimately culminated in a new ordinance which was designed to curb his disruptive activities in events that exceed 50 people. It also strengthened the Police Dept's prerogative in separating opposing demonstrators. Many in the Tea Party opposed this new ordinance because they correctly perceived that it would

apply to them, as well, and there are Constitutional issues. In fact, in May 2018, Rawls violated numerous existing ordinances, with impunity, while the police stood by. However, it was the Tea Party that was cordoned off and threatened with arrest. The Tea Party had violated no ordinances. The Town Crier's perfect seven year record of demonstrations on St. George Street, were without a single incident involving the police or any disruption occurring, notwithstanding.

Because of the new ordinance, the Tea Party chose not to engage the Rawls demonstrators. This is true also of the 3% Militia. Both groups were in the audience, and observed at close hand, the activities of those whose goal was to disrupt the festivities. One of the chants was, "Sorry about your Christmas lights, but we're in a bigger fight." This is a completely true statement. They are engaged in a Cultural War to undermine the values that bind this nation together. Another chant was, "This is what democracy looks like." A very true statement! The very nature of Democracy is 'mob rule' and with this chant they discredited themselves among those who bear witness. The Communists are their own worst enemy. They always play to each other and, consequently, repel the public.

Last year, it was all about the destruction of Veteran's Memorials. For the time being, Rawls has lost that battle. And he credits racism as the reason for his defeat. In the picture on the left, the sign they carried calls his one-time ally, Mayor Shaver, a Racist. In fact, according to Rawls, everybody is a racist and St. Augustine is

the most racist city in America. He spent a large portion of his evening screaming at the top of his lungs, "RACIST, RACIST RACIST, RACIST," while he wore, the collar of his AME Church.

The SATP Chairman added the follow comment,

"If you listen to the Progressive Communists on the left, you would have to reach the conclusion that slavery, Jim Crow oppression and anti-civil rights opposition concurrently exists today. The facts are that slavery ended 153 years ago. The Jim Crow days are long gone, and even the civil rights opposition ended 54 years ago. There was a time in America when real racism prevailed. I am old enough to have witnessed some of it in my youth. However, in all my years I have never seen a man, black or white, more racist than Ron Rawls. I am not name-calling here, but making a definitive statement. The man is obsessed with racism. To say that America is racist, today is simply a gross distortion. Are there racists in our society? Yes, and they will be with us forever. Do they have the power to suppress the black people? The answer is absolutely no. A black man today can do anything he sets out to do. He can even become President of the United States. The Progressive Communists need victims and they impose on their captive plantation victims a sense of failure that is almost criminal in nature. The good news is that many black people are walking away. Recently, a black patriot attended our Tea Party talking about the 'WalkAway' program. This is so exciting, the idea of black people being free from those who exploit them."

St. Augustine's version of "Pravda" the St. Augustine Record reported that Rawls said he was pleased with what happened. "We went to disrupt and we disrupted," he said. The reality of the situation was that Rawls did not disrupt, he was either ignored or criticized by the people he encountered. Rawls simply did not have enough people to have an impact on the 5000 people that were occupying the Plaza. Loudspeakers playing music drowned out even their obnoxious chanting. With the population density inside the Plaza as great as it was most of the pubic were not aware of the demonstrators.

According to the Record Rawls estimated that he was joined by 150 protesters. The Tea Party counted their numbers as they marched by before they broke into smaller groups so they could appear to be on each side of the Plaza at the same time. The actual number of demonstrators was 58. There

were several that were counted, who may have just been part of the public who got swept up with the group. We say this because they were carried no signs and did not appear to be dressed as the protesters were. At one point early in the demonstration, it appeared there were more "ACLU Legal Observers" than there were protesters. It was amusing to see them try to convince the public that they were neutral. In fact, they never left the Rawls group, marching all the way back to the AME Church.

SAPD Continues Special Treatment for Rawls

The St. Augustine Tea Party, when demonstrating in public areas, has always understood that they could not block or impede normal pedestrian traffic on a public walk. The city's ordinance regarding picketing

expressly prohibits it. Never, in its entire seven years, has the Tea Party had a police escort. However, black has its privileges. And one of them appears to be police escorts for their activities. Last year at the Light Up event the police escorted them right up to the pavilion where Christmas music was being played. The new ordinance prohibits them being inside the Plaza restricting them to the sidewalks on the perimeter of the Plaza. It appears that the demonstrators have priority over attendees to the event. Tea party volunteers witnessed police officers ordering the public off the walk so that the Rawls' group could proceed effortlessly. Volunteers have witnessed police escorts on St. George Street as well. When Chief Fox was asked about it some months ago, he acknowledged that a problem existed if in fact this was going on.

Police Chief Barry Fox was on the front line with his officers at last night's Nights of Lights light up. The pictures here were taken before volunteers witnessed the escorts. Chief Fox is shown talking to Tea Party member Doug Russo. The escorts were witnessed on the Cathedral Place side of the Plaza where these photos were taken. Equal justice under the law is paramount to our continued existence and it doesn't matter if it occurs at a local or a federal level. Clearly Chief Fox had to be aware of what was going on regarding the escorts.

Is Rawls in his Twilight?

There was a time when Rawls had greater numbers, better media coverage and support within the City Commission. Clearly over the past year, this has been dwindling. At the previous Nights of Lights event, the Three Percent militia counted 63 participants. The city claimed 163. As pointed out previously an interesting play on numbers. This year he had 58, with the possibility that the number actually was more like 54. His last outing on St. George Street and dwindled to about 12. And his great "Selma Styled March" in May, 2018 from Jacksonville to St. Augustine, in which no one actually marched the full distance, was 47.

The Tea Party, asks the question, how long will our city officials rollover for the outrageous behavior of a bully, priestly collar or not?

JFK 55 Years ago Today

John Fitzgerald Kennedy, the 35th President of the United States, was assassinated on Friday, November 22, 1963, in Dallas, Texas, while riding in a presidential motorcade through Dealey Plaza. JFK was, at the time, considered a Liberal. The term Progressive was not fashionable in his day. Kennedy was adored by the media of the time, much in the same manner that Obama was more recently. JFK, during his 1000 days in office, enforced the "Monroe Doctrine" by keeping a Soviet first strike capacity out of Cuba. JFK's loyalty to the country was never in question. He served honorably as a naval officer during World War II. In an effort to stimulate the economy, Kennedy cut taxes in the same manner that Reagan did 20 years later. The civil rights movement started, in earnest, during his administration and his response to it was based on the founding documents.

Barry Goldwater had written a book, I believe in 1960, entitled "The Conscience of a Conservative". "The millenniums" of the early sixties, the young people, embraced the conservative movement in the same way that later generations of young people would embrace the libertarian movement of Ron Paul. Barry Goldwater put America first, much in the same way that Donald Trump does today. The coming election in 1964 was to be between Barry Goldwater and John Fitzgerald Kennedy. Goldwater and Kennedy had planned to tour the country together by rail during the campaign. They called it "whistle stopping" back then. JFK's assassination changed all that.

This was the world of politics that started my political activism. I joined the Republican Party and became an operative for Barry Goldwater.
