It's About the Young People

On Tuesday, February 26, 2019, the St. Augustine Tea Party (SATP) conducted an open meeting at the Village

Inn, in St. Augustine Florida. The featured speakers were students from St. Augustine High School. Prior to the meeting being called to order, David Heimbold staged a pep rally that resulted in USA chants that could be heard throughout the restaurant. This was something never done before according to Tea Party sources. It set the mood.

Tea party Chairman, Lance Thate, provided the Chairman's report, part of which was directed towards the young

According to Logan, many of the TARS members, who wanted to attend the Tea Party meeting, had been intimidated by both other students and High School staff. The result was that they stayed away to avoid trouble. According to numerous parents, the school administrators are doing little or nothing but stalling. The Civil Rights violation to Logan and other TARS members has been going on for months.

This was an outstanding meeting for the Tea Party because the level of support for the young people, from all of those in the room, was overwhelming. Clearly the public is concerned about this issue. People from five surrounding counties representing various groups pledged support for these young patriots.



One particular moment was when Lucky Howe acknowledged the bravery of these students. Mr. Howe knows something about bravery. He served in the South Pacific during World War II. He encountered many brave men. He told the Teenage Republicans that when you stand for the truth you usually stand alone.

It remains to be seen how this level of support will unfold. The Tea Party business meeting, scheduled for the 5th March, will undoubtedly take up the Tea Party's role in this issue according to Chairman Thate. If the people in attendance follow through, the school



St Patrick's Day Parade Revisited and Visited

On March 9, 2019, the 9th Annual St. Patrick's Day Parade was held in the historic district of St. Augustine, Florida. The parade is used to promote the St. Augustine Celtic Music and Heritage Festival at Francis Field.



The St. Augustine Tea Party (SATP) has had an entry in six out of the last nine St Patrick's Day Parades. In 2013, the Tea Party chose not to participate. In 2017, we were refused entry because of an alleged 'late filing'. We were also refused entry in 2018. Pat Syeles, an organizer for the event, initially refused our entry because we were too political. She made this claim in spite of the fact that democratic organizations displaying the

perverted rainbow symbols have been permitted. After about a two hour negotiation with Mrs. Syeles, she agreed to permit the Tea Party's 38 foot Dartmouth in the parade on the condition that a "Parade Marshal" would be assigned to the SATP entry. Parade Marshals are not generally assigned to individual entries. As the parade proceeded, it became clear that the purpose of the Parade Marshal was to bully and harass our crew and to police our activities. The Parade Marshal was particularly offended by our own security who marched in front of the tow vehicle. They carried 3% Militia flags and Blue Lives Matter flags. This infuriated the Parade Marshal and the organizers who assigned him. At the end of the parade, the Parade Marshal physically assaulted Tea Party Chairman, Lance Thate, and attempted to restrict his movement. A report was filed with the St. Augustine Police Department.

Tea Party Conducts Open Meeting at Village Inn

On March 26, 2019 the St. Augustine Tea Party conducted an open meeting at the Village Inn in St. Augustine Florida. Their guest speaker was Henry Gutierrez. Mr. Gutierrez was an eyewitness to the destruction of his native land by Marxist Communists. The parallels of what happened in Venezuela are present today in the United States. The Venezuelan sounded the alarm at the Tea Party meeting.

Mr. Gutierrez has only been in the country for about a year and has applied for political asylum. His story was read by SATP Media Chairman David Heimbold. The text of Gutierrez's presentation is presented as follows:

"I was born and raised in Venezuela, a country which I love and miss dearly. I have three brothers and four sisters who are suffering from the ravages of a dictatorial regime, which, through the use of the national armed forces (the collective strength, criminal civil armed, trained to intimidate civilians opponents) and the narco-trafficking organizations that dominate the borders of Colombia, detain and torture all civilians who oppose Maduro's communist ideas and his will to power.

I spent 8 years of study and work to help my family get ahead. My parents were not educated and their income came only from my father, who worked as waiter in a restaurant. Therefore, the income was limited to support a family of 10 people. However, the food and the medical services were there, thank God. We lived in a country based on democratic principles, despite the corruption, the buying power allowed us to cover the basic needs. Today that is not possible.

At the age of 16, I started my career as a programmer of computerized systems. I was hired by an Agency Shipping Company to develop a small control system of human resources. I caught the attention of the shipping agent, to start my studies in the English language, which was necessary for communication with ship

operators and crew. I reached the position of Operations Analyst Shipping line or shipping agent. When I visited the docks of the Petrochemical Complex, I felt the need to become an Engineer to achieve entering the world of manufacturing and operations of Petrochemical Plants. I applied to work in Polinter, in 1997, to work as a Logistics Coordinator.

In 1998, an election year, the candidate of the left, was retired military, helped and trained by Cuba in the years prior, took advantage of the shortcomings and deficiencies generated by the political corruption of that time, to infiltrate and win the election. He pledged to help the poor, through a socialist system, which would respect private property, encourage the national production, reduce the salaries of politicians, the expenditures in security and more.

This is what I, particularly, call the Cuban franchise; the same process, to fall in love with the poor, the ignorant, those who want to have everything without working hard, the innocent, and the captive.

I must admit that I was among the dupes. I had not the least idea of the importance of participating in a Presidential election which, in the future, would end up with the disappearance of all that I spent 30 years of hard work and studies building.

I graduated from Industrial Engineering with a Masters Degree in Logistics Management, while working in the only Company that produced Polyethylene in Venezuela and one of the biggest of Central and South America. With love and pride, we worked more than 11 hours a day, to achieve the export of over 200,000 tons of Plastic Resins for all of Latin America and Europe in the year 1997. Today we are not producing enough to cover our national consumption.

Venezuela did not use the oil boom to save for the lean season, but ended up with five times the external debt, through loans and mortgaging the country up to 25 years. Between 1999 and 2014, Venezuela received US dollars in the amount of \$960,589 million; an average of \$56,500 million US dollars a year for 17 years. All is lost.

The current President, Nicolás Maduro is to blame for the crisis, yet he blames the United States of America for the crisis. He is the one responsible for the fall in oil prices and oil production. Before the arrival of the so-called socialism of the 21st century, Venezuela had an efficient and reliable system of production and distribution of electrical energy, even exported to Colombia and Brazil. Today we suffer with up to 6 hours without lights in some states of the country and, just a week ago, the entire country was without electric service for more than 5 days. All the food that requires refrigeration was spoiled. Hundreds of patients who were in intensive care units died, also newborn infants, among many others. All of this can be seen in the news of the main national and international newspapers.

In fact, my father passed away in December of last year due to lack of medicines and professionally trained health care. My greatest frustration and sadness is that I could not go to see him, since I'm pursuing political asylum in this country and I cannot travel because of the threat of death of myself or a member of my family. I have a little girl, 10 years old and another 5 years old. I am threatened for not wanting to approve the payment of some projects that were not executed, that is to say, by denouncing acts of corruption in the company. Everything in the country is based on corruption and anarchy.

To cite another example of the great scam called socialism, PDVSA, our main producer and exporter Petroleum Company, produced 3.7 Million barrels per day in 1970. Today, less than one million barrels a day is produced.

I don't have the time to enumerate all the failures that Socialism or Communism brought to my country during these 20 years of the so-called Bolivarian revolution and/or socialism of the 21st century; led by the Government of Cuba, with the support of Russia and China, to take advantage of and steal the wealth and resources of Venezuela. Suffice it to say that the whole of our national production is destroyed.

We are not Only missing the money that we'll never get back, also wasted years of work to achieve the Venezuela that we had 20 years ago.

As Margaret Thatcher said "Socialism fails when you run out of other people's money".

In order not to repeat formulas that bring poverty, starvation and death it is necessary to reason with data that not only exists, but that sadly abounds. I'm not required to be a historian to know that Socialism does not work.

Finally, I want to mention a summary taken from an article of de Lee Edwards, *leading historian of American conservatism and the author or editor of 25 books*, about Why Americans Must Know About Socialism,

1.- Socialism is no longer a parlor game for academics but a political alternative taken seriously by millennials.

2.- They don't recognize that much of what they enjoy in life is a esult of Capitalism and would disappear if socialism were to be implemented.

3.- This is the reality of socialism — a pseudo-religion grounded in pseudo-science and enforced by political tyranny."

Trump, Trump, Trump, the Tea Party marches on.


