## So who is going to be POTUS in 2020?

The St. Augustine Tea Party's Town Crier Committee has been engaging the public in the historic district of St. Augustine, Florida since June of 2011. The Town Criers have developed a skill in listening and responding to the public's political responses. What started out as informal questions in 2012 evolved into formal polling by January of 2015. The Criers started calling it the "St. George Street Poll". Six million people visit the historic district of St. Augustine annually. The demographics on the street are a national representation and each day brings a new group of people.

The St. George Street poll is a random selection face-to-face polling. While the poll may not be scientific, if you compare them to the polls of the political parties and the media, the demographics of St. George Street have enabled the Town Criers to make certain predictions over the years. The Town Criers, based on their polling, predicted the presidential outcomes of the Romney and Trump campaigns before either candidate was even nominated by their respective party.

Back in January of 2015, there was a lot of talk about having a woman President. Most of this conversation came from Hillary Clinton and the mainstream media. At the same time the media viciously attacked Sarah Palin. To test the effectiveness of the media the Town Criers conducted their first formal St. George Street Poll. On January 31, 2015 the public was asked to choose between Palin, Clinton or neither. The results were astounding: Palin 74%, Clinton 6% and neither 20%. When Clinton announced formally that she was a candidate for the Presidency in April, 2015, the question was asked again on April 18, 2015 by the Town Criers with the following results: Palin 79%, Clinton 7% and neither 14%.

# Media Beating the Drum for Biden

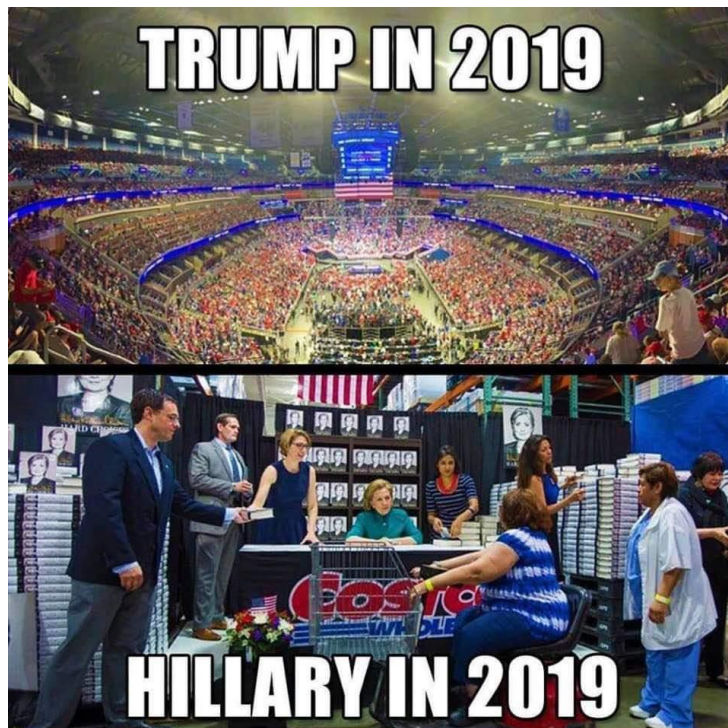
