On July 30, 2020, during the early evening hours, a candlelight prayer vigil was held in the Historic District of St. Augustine, Florida. About 35 people assembled along the fence that was erected by the City in anticipation of the destruction of the historic monument which has been standing there, peacefully, since 1879. Descendents of the soldiers who perished and whose names are inscribed as a memorial were among those present. The descendents of the soldiers have filed a lawsuit and were asking for an injunction against the City’s wanton destruction of history.

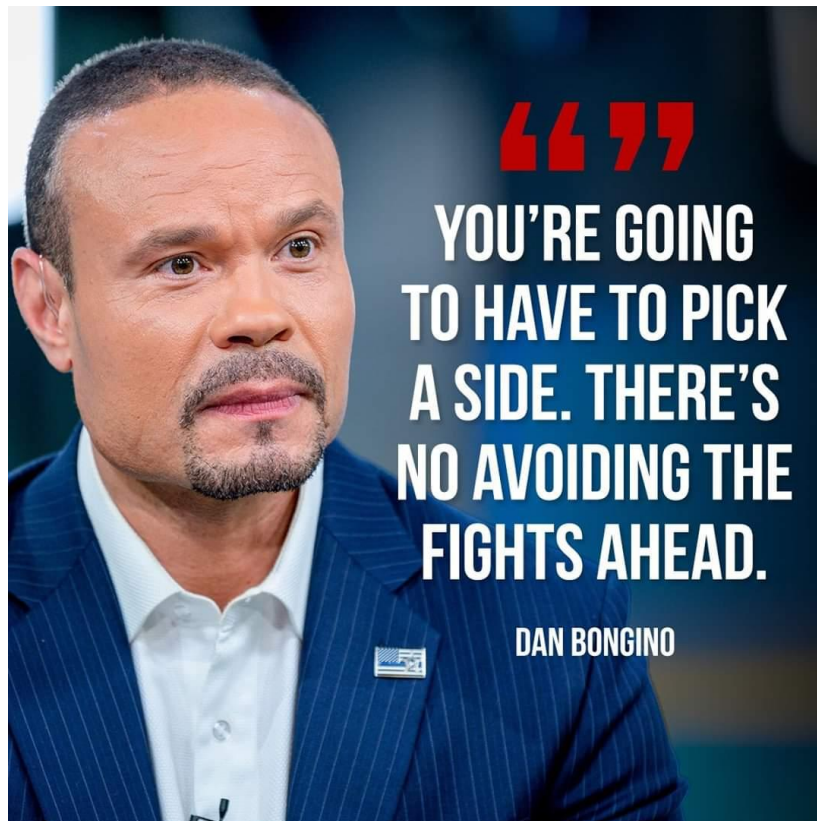
The following day, July 31, 2020, the case was dismissed for lack of standing. Of the various lawsuits filed in the State of Florida, this is a common outcome. It does not seem to matter whether it is State court or Federal court. To the anguish of those who hold liberty dear, the decision by the court reflects how deeply the communist agenda has infiltrated the justice system.

It's Time for Operation Push-back, America

Protest Goes to New Seat of City Governance

On August 1, 2020, screaming motorcycles and a caravan of trucks and autos carrying dissatisfied citizens proceeded to the new seat of City government in the residential area known as Davis Shores. It seems that the City Commissioners no longer feel safe in their Commission Chambers located at City Hall. So the last couple of Commission Meetings have been conducted from their homes. According to protester and Tea Party member, Doug Russo, "It makes their homes fair game since official power now resides there and is administered from their homes, not City Hall." The focus of the protest on August 1st was directed at Mayor, Tracy Upchurch. Tracy Upchurch was appointed as Mayor, by the communist leaning City Commissioners, when then Mayor, Nancy Shaver, was forced to resign because of health conditions. It was primarily Mayor Upchurch's leadership that caused the City to reverse its position regarding the Veteran's Memorial. Mayor Upchurch now has the wrath of the entire County on his head. The Mayor and Commissioners only warranted two patrol cars. But the City bureaucrats, the real power at City Hall, digging at the monument warranted 15 squad cars. This show of force was summoned to challenge one lone woman who was emotionally wrought. She was crying because her family name is inscribed on the monument and she could not handle the thought of the monument being destroyed. The site of workmen digging around the monument caused her to shake the chain-link fence and plead with the city employees to stop. This infringement upon the 'sacred' fence which the City so quickly installed caused, yet, another overreaction of the St. Augustine Police Department.

It will be remembered that on or about July 1st, Patriots assembled in a vigil and attached flowers and flags to the chain-link fence. Many of them were placed there by children. Six Police Officers came and demanded the removal of the flowers and flags. When the Patriots refused to remove them, Police Officers took up the task themselves. Videos of the Police Officers removing the flowers and flags and then throwing them into the trash, including flags, were widely spread on social media. It was an extremely embarrassing event for the St. Augustine Police Department and Police Chief Fox.

Commissioners, Nancy Sikes Kline's and Leanna Freeman's homes were also visited by the disgruntled citizens. Upchurch, Sikes Kline and Freeman voted to have the monument removed. Based on the construction of the monument, removal translates into destruction.

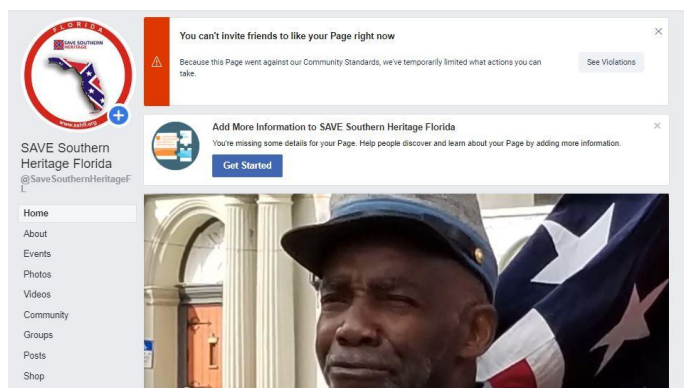
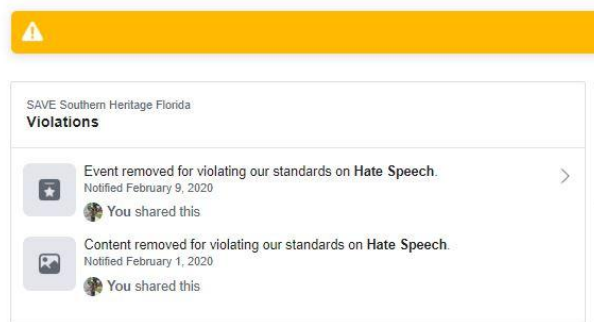
Dear Miss Lunelle,

And I who served on the Buncombe County Commissioner Task Force to re-write the City of Asheville, Buncombe County Joint Minority Business Plan...I who served as Chair Emeritus of the Board of Advisors of the Southern Legal Resource Center; a non-profit Civil Rights Law Firm that specializes in litigating Southern Heritage Civil Rights violation.

I who would don the uniform of the Southern soldier with the Southern Cross in hand, marching some 1,600.1 miles from Asheville, North Carolina to the Supreme Court building in Austin, Texas on the Historic March Across Dixie while receiving from the black Mayor in Toccoa, Georgia, the Key to their City, and not to forget,

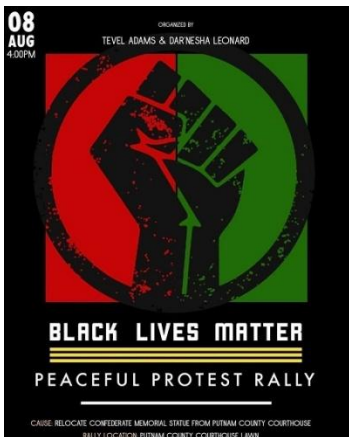

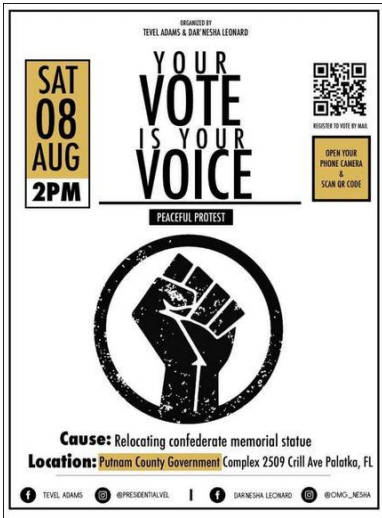
What these diverse groups have in common is an understanding that the political parties are not going to resolve the issues that confront the division in our Country. The Democrat's platform is in lockstep with the agenda of the Communist Party USA. This Council's discrimination and systematic eradication of the memorials of an integrated armed force of

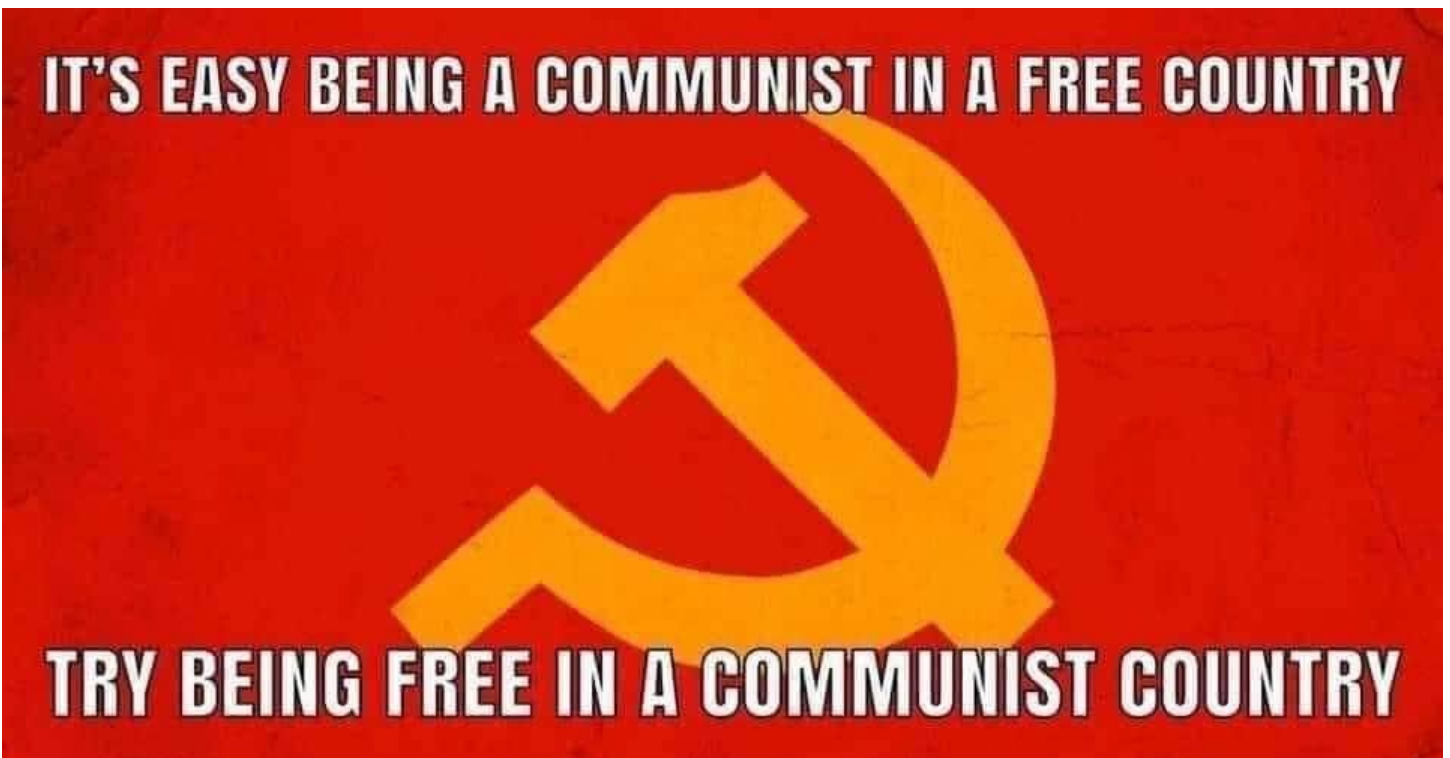

It takes Courage to be Free

About 30 demonstrators assembled at the foot of the Bridge of Lions in the historic district in St. Augustine Florida on August 22, 2020. It was a part of a continuing protest of the City's decision to remove the oldest Historic Veteran's Memorial in the State of Florida from public view. This Monument has been a

multi generational connection for families here since 1879. Those family names are now being dishonored.

Over the course of nearly 2 months, Conservatives have been demonstrating that they have the capacity to put several hundred protesters into the streets to confront the communist organizations such as Black Lives Matter, Occupiers and the Women's March. These Marxists controlled groups have been waging war against the Oldest City on the North American continent. When there is no opposition expected, the Marxists consistently produce demonstrations with only 30 to 50 people. The Conservative groups are highly motivated and produce numerous events such as Vigils, trips to the City Commissioner's homes, (the new seat of government during the pandemic hoax) and Sign and Flag Waves such as the one that occurred today.

The frequency and depth of the Conservative protests have not gone unnoticed by the St. Augustine Police Department. (SAPD) The Police Department has been implementing a policy of intimidation against the very citizens they are sworn to protect. There was a time when the SATP's Town Crier activists were pretty much

ignored by the SAPD. The Town Criers have demonstrated about 300 times over the last nine years without a Police incident. But with the advent of “Community Organizer” Ron Rawls and his importing of agitators from Jacksonville, police intimidation has raised its ugly head three years ago. Lawful ordinances are ignored and arbitrary commands are implemented with different standards for different people. This is fertile ground for intimidation.

With the current situation regarding the removal and or destruction of the 1879 Historic Memorial, one of the first things that they did was to put up a police barrier around *the fenced construction site*. *The SAPD has a history of cordoning off the public with police barrier ribbons, even in public meetings.* To facilitate the construction, they closed part of the sidewalk on King Street and then challenged any demonstrator that dared to set foot onto the Street with threats of arrests.

On July 26, 2020, the editor and publisher of this publication had the opportunity to interview SAPD Chief, Barry Fox. Fox expressed his concern that we have dangerous people out there. He was concerned that there might actually be people who will push back against the communists and said that that would be a dangerous situation. The intimidation and the failure to apply the rules equally were raised. His response was, “Why didn’t you contact me?” The answer was, “I did, several times.” His final comment, “Well, I don’t have to do this. I have more than enough time in to retire. I do this because I love my City and I love the people.”

We once thought that Fox was simply carrying out John Regan’s orders; Regan being his immediate supervisor. But his zeal in providing extraordinary security for Rawls, Upchurch and other left-wingers at the St. Augustine Historical Society meeting, some years ago, has to be considered. His “beloved people” had the audacity to show up for public meetings, when their presence was not appreciated. Fox then put up a police line to cordon off the common people and the elite members of the board.

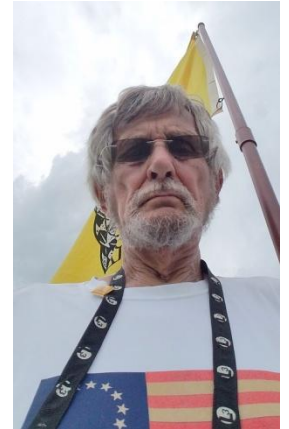
There were several large Conservative demonstrations in the Plaza de la Constitucion in July. A focal point for the events was the Gazebo, from which speakers could address those in attendance. The SAPD has now seized the Gazebo, placing barriers around it, thereby restricting First Amendment rights to peaceably assemble. But is there is any doubt about Fox’s loyalties? All uncertainty is dismissed by his attack on free speech. Only for Conservatives, a zero-tolerance for the use of megaphones is in place. Tea Party member and long-standing Town Crier, Doug Russo, reports that a police officer tried to trick him into turning on a megaphone that he was carrying so that he would be arrested. Russo has been playing this game long enough to know better than to take that kind of bait. We know, from conversation with Fox, that Russo is considered a target for harassment. When they couldn’t get Doug they went after Jamie Parham for using a megaphone. Multiple SAPD officers swarmed him, cuffed him and arrested him after he asked why they let Rawls use the megaphones without a permit. That’s when Sergeant Whitehead yelled to the officers, “Cuff Him!”

. Double Standard

Every restriction being placed on Conservative protesters does not apply to the communist organizations. For three years, the communist's use of a bullhorn or megaphone and beating on drums has been considered free speech by the St. Augustine Police Department and still is. If Rawls steps out onto the street, the Police Chief directs traffic to allow him to do whatever he wants. There are no police lines for Rawls. He goes where he pleases and the police escort him to protect him. Rawls is never intimidated or bullied by the police.

The Flag and Sign Wave Revisited

We need to revisit the demonstrators at the foot of the Bridge of Lions at the start of this story. "Flag and Sign Waves are great ways to have fun," Town Crier and Tea Party Chairman, Lance Thate stated. "Over a ten year period I've never been to one that wasn't a success. The public loves the Conservative demonstrations. They love to blow their car horns in approval. But there's something wrong here. The people assembled here were convinced that if they went into the Plaza they would be treated like domestic terrorists and dealt with harshly by the Police." According to Thate, the Town Criers were there as observers and reporters for their publication. The organizers of this event were not present. Many of the protesters have never participated in political demonstrations before formation of their groups, in some cases, less than a month ago. The battle to save the Monument will not be accomplished with Flag and Sign Waves. The battlefield will be in the Plaza at the Monument. To put to rest the fear that has been created, the seasoned Town Crier street fighters, along with some new recruits and a couple of adventuresome souls went into the Plaza to engage the Police. Plaza protestors reminded the police officers of their Oath of Office. They read the text of Trump's Executive Order about removing Monuments to the police officers. And the officers were asked point-blank if there was any reason that demonstrators would be ejected from the Plaza. The fears that the protesters had, wherever they came from, were totally and completely based on nothing real.
